She initiated the development of a community and health system-wide advance care planning program and was instrumental in establishing a post-acute care network with expectations, agreements, and measures for Spectrum Health

Dr. Gruber is responsible for a rehabilitation and long-term care facility, family bereavement center, homebased primary care services, facility provider services, and other homebased care programs, including home health care, home infusion, and non-emergency medical transportation. Additionally, she is a liaison with other community-based organizations to align and expand community-based care serving as a board member for the local Area Agency on Aging, vice-chairperson of PACE (Program of All-Inclusive Care for the Elderly) Southwest Michigan, Berrien County Cancer Service, and chairperson of the Health Berrien Consortium. Dr. Gruber serves on the National Hospice and Palliative Care Board of Directors and is chairperson of the National Council of Hospice and Palliative Care Professionals. Currently, Melinda is also serving as the Interim President of Spectrum Health Lakeland Foundation.
